The ICDA Board has developed a proposed accreditation process based on feedback from members, and looking at those of similar international organisations. The Board now seeks input from dietitian-nutritionists experienced in education, accreditation, curriculum development and the like, to provide advice and guidance to take this program to the next stage. Participants will provide advice to the ICDA regarding implementation and how best ICDA can locate champions and assessors within countries around the world..
